Government of Nepal (GoN) has allocated fund towards the cost of Agricultural Infrastructure Development and Mechanization Promotion and intends to apply a portion of this fund to eligible payments for the consulting services for which this Expression of Interest is invited for National Consulting Service.

The Center for Agricultural Infrastructure Development and Mechanization Promotion now invites Expression of Interest (EOI) from eligible consulting firms ("consultant") to provide the following consulting services:

The Centre for Agriculture Infrastructure Development and Agriculture Mechanization Promotion (CAIDMP) invites **EXPRESSION OF INTEREST (EOI)** from the national consulting firms or joint venture (JV) of firms ("consultant") for the purpose of short listing the qualified, eligible and experienced consultant for the above-said consulting services. However once short-listed, JV partners are unchangeable. Minimum years of General Experience of the firms shall be 5 (Five) years. The interested firms or JV of firms having experience in similar works shall submit the EOI containing following document.

1. Corporate Registration Certificate
2. VAT/PAN Registration Certificate
3. Tax Clearance Certificate (FY 2074/075)
4. Joint Venture Agreement (if applicable)
5. Description of the works completed within last Seven years
6. Audit Report and Financial Statements (last five fiscal years)
7. List of Professional Staffs and key personnel along with their qualification and work experiences to be assigned for the work
8. List of the equipment, office space and facilities owned by the firm or JV of the firms
9. Organization Profile

All four assignment are different tasks; if any consultant firm or JV intend to apply for more than one need apply separately with different set of human resources and other requirement.

EOI shall be delivered online through e-GP system <https://bolpatra.gov.np/egp> to the address below on or before January 15, 2019 office hours. The EOI will be open 12.30 onwards on 16 January 2019.

If the last date of submission of the EOI happens to be a public holiday, the next working day shall be considered as the last date of submission.

EOI will be assessed based on Qualification 40%, Experience 40%, and Capacity 20% of consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a Request for Proposal (RFP).

Minimum score to pass the EOI is 60.

The evaluation of EOI shall be made based on prevailing laws of Nepal, namely the Public Procurement Act, 2063 and Public Procurement Regulation, 2064.
